## **CHARGES**

Police Officer Mazyar Hariri, Star Number 16607, is charged with violating the following rules contained in Article V of the Rules and Regulations of the Chicago Police Department, which were in full force and effect on the date of the alleged violations:

Rule 2: Any action or conduct which impedes the Department's efforts to achieve

its policy and goals or brings discredit upon the Department.

Rule 14: Making a false report, written or oral.

Rule 15: Intoxication on or off duty.

Rule 38: Unlawful or unnecessary use or display of a weapon.

## **SPECIFICATIONS**

1. Police Officer Mazyar Hariri, Star Number 16607, is charged with violating Rule 2, "Any action or conduct which impedes the Department's efforts to achieve its policy and goals or brings discredit upon the Department," in one or more of the following instances:

Count I:

On or about February 11, 2015, at about 0100 hours, at or around the 6200 West block of Bertreau Avenue, in Chicago, while off duty, Officer Hariri placed a semi-automatic Glock Model 17 9mm pistol, serial number LYH245, into his mouth in the presence of one or more members of his family, thereby impeding the department's efforts to achieve its policy and goals and/or bringing discredit upon the department.

Count II:

On or about February 11, 2015, at or around the 6200 West block of Bertreau Avenue and/or Resurrection Medical Center, in Chicago, while off duty, Officer Hariri was intoxicated and/or registered a .103 BAC on a breath alcohol test, thereby impeding the department's efforts to achieve its policy and goals and/or bringing discredit upon the department.

Count III:

On or about August 19, 2015, at about 0900 hours, at or around 3510 South Michigan Avenue, in Chicago, when asked by Sergeant Andrew Stewart of the Bureau of Internal Affairs whether he had put his gun in his mouth and/or whether he said that maybe he will kill himself and then put his gun in his mouth, or words to that effect, Officer Hariri stated "No, I did not," or words to that effect, thereby impeding the department's efforts to achieve its policy and goals and/or bringing discredit upon the department.

- 2. Police Officer Mazyar Hariri, Star Number 16607, is charged with violating Rule 14, "Making a false report, written or oral," in one or more of the following instances:
  - Count I:

On or about August 19, 2015, at about 0900 hours, at or around 3510 South Michigan Avenue, in Chicago, when asked by Sergeant Andrew Stewart of the Bureau of Internal Affairs whether he had put his gun in his mouth and/or whether he said that maybe he will kill himself and then put his gun in his mouth, or words to that effect, Officer Hariri stated "No, I did not," or words to that effect, thereby making a false report, written or oral.

- 3. Police Officer Mazyar Hariri, Star Number 16607, is charged with violating Rule 15, "Intoxication on or off duty," in one or more of the following instances:
  - Count I:

On or about February 11, 2015, at or around the 6200 West block of Bertreau Avenue and/or Resurrection Medical Center, in Chicago, while off duty, Officer Hariri was intoxicated and/or registered a .103 BAC on a breath alcohol test, thereby being intoxicated while off duty.

- 4. Police Officer Mazyar Hariri, Star Number 16607, is charged with violating Rule 38, "Unlawful or unnecessary use or display of a weapon," in one or more of the following instances:
  - Count I:

On or about February 11, 2015, at about 0100 hours, at or around the 6200 West block of Bertreau Avenue, in Chicago, while off duty, Officer Hariri placed a semi-automatic Glock Model 17 9mm pistol, serial number LYH245, into his mouth in the presence of one or more members of his family, thereby unlawfully and/or unnecessarily using or displaying a weapon.

Based on the foregoing charges and specifications, the Superintendent recommends that Police Officer Mazyar Hariri, Star Number 16607, be discharged from the Chicago Police Department.
